

CLAREMONT LEAGUE 2024 NOTICE OF RACE

The Organising Authority (OA) is Howth Yacht Club CLG.

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a)

1. RULES

Racing will be governed by the Racing Rules of Sailing, the prescriptions of Irish Sailing, the Sailing Instructions (SI) and any amendments thereto.

2. SAILING INSTRUCTIONS

Sailing Instructions (SI) will be made available on the HYC website before racing.

3. COMMUNICATIONS

The online official notice board is located at https://hyc.ie/open-events

4. ELIGIBILITY AND ENTRY

- 4.1 Racing is open to ALL dinghies.
- 4.2 Classes are defined as follows:
 - Mixed Handicap racing under the PY system
 - Optimist
- 4.3 Boats may enter the event by registering online at https://hyc.ie/open-events
- 4.4 To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees.

5. FEES

The entry fee is €65.00.

6. SCHEDULE

Races will be held on Sunday mornings from 22nd September 2024 to 13th October 2024. First Warning Signal is at 10:25

It is proposed to sail three sprint races per day.

7. VENUE

The Race Area is between Howth Harbour and Ireland's Eye.

8. COURSES

The courses will be Windward – Leeward and Triangle, Committee Boat starts detailed in the Sailing Instructions

9. SCORING

- 9.1 Scoring shall be as per RRS Appendix A4, low points system. The PY handicap system will be used for the Mixed Handicap Class
- 9.2 Appendix A5.3 will apply.
- 9.3 A boat's series score shall be the total of her race scores excluding her worst score.
- 9.4 For the last scheduled race, RRS A4 is changed so that the points are doubled.
- 9.5 The score for the last scheduled race shall not be excluded from the event score.

10. DATA PROTECTION

Competitors give their consent to the OA to use or to license the use of their name, comments, photographs and likeness as it sees fit for the promotion of the Regatta. The OA reserves the right to uses or to license the use of any images and sound recording during the Event free of charge.

11. RISK STATEMENT

Rule 3 of the Racing Rules of Sailing states: 'The responsibility for a boat's decision to participate in a race or to continue racing is hers alone.'

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

- (a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- (b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
- (c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions:
- (d) Their boat is in good order, equipped to sail in the event and they are fit to participate;
- (e) The provision of a race management team, patrol boats and other officials and volunteers by the event organizer does not relieve them of their own responsibilities;
- (f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;
- (g) It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event;

12. INSURANCE

Each participating boat shall be insured with adequate, valid, third-party insurance cover.

13. PRIZES

Prizes shall be awarded for each class on the basis of average turnout as follows:

- 2 boats 1st
- 5 boats 2nd
- 8 boats 3rd

The prize giving will be held after racing on 13th October 2024.

14. OTHER INFORMATION

- 14.1 All Boats competing must display a HYC sticker on the transom. These will be provided upon registration at HYC.
- 14.2 Single handed boats' masts must be stored with the sections separated.
- 14.3 Road trailers are not permitted in the Dinghy Park other than for delivery or collection of boats. It should be noted that any offending trailers will be removed and parked on the pier at the owner's risk.
